According to the Article 5 of "The Public Debt Act" enforced on January 1, 2014, the ceiling of outstanding public debt with a maturity of 1 year or longer incurred by the central government is subjected to the average of nominal Gross Domestic Product (GDP) for the previous 3 fiscal years. To facilitate annual comparisons, data for years before 2014 is adjusted to the same criteria.

6. As the end of March 2026, the actual outstanding debt was 5,992.9 billion NT Dollar, accounting for 23.04% of the average GDP for previous three years.
