Notes:

1. The figures in Column A represent the number of seizures made by local governments, including those made independently by local authorities and those made in collaboration with enforcement agencies such as The Third Special Police Corps, National Police Agency, Coast Guard Administration, harbor police, and the Investigation Bureau.
2. The figures in Column B represent the number of seizures made by Customs and ports of entry :
  - (1) Before the year 2013, this includes the number of seizures made by Customs independently as well as in collaboration with enforcement agencies such as the Coast Guard Administration, The Third Special Police Corps, harbor police, and the Investigation Bureau.
  - (2) After the year 2014, at the request of Customs, the figures for seizures made by Customs independently (Column b1) and those made in collaboration with the aforementioned enforcement agencies (Column b2) are separated.
3. From January to March 2026, a total of 416,109 packs of illegal heated tobacco products were seized.
