## 填表須知 INSTRUCTIONS

本申請書為「進口酒類查驗管理辦法」（以下稱本辦法）第 8 條規定之必要文件，申請進口酒類查驗者應依下列說明填寫：

This application form is a required document in accordance with Article 8 of The Administrative Regulations Governing the Inspection of Imported Alcohol. The obligor of the application should fill in this application form according to the following instructions.

1. 「查驗申請書號碼」欄：共 14 碼，已向財政部領用預撥案號之報驗人，請依預撥案號先後順序使用填寫，未向財政部申請預撥案號者，免填。

“Inspection Application No.”: It is 14-digit number. The obligor of the application who has already accessed the pre-application number from the Ministry of Finance shall fill it in sequence; on the contrary, any obligor who has not accessed the pre application number from the Ministry of Finance should not fill it in.

2. 「申請查驗義務人」欄：

“Obligor of the Application”:

- (1) 申請查驗義務人是指酒類進口人。

The obligor of the application is the importer of alcohol.

- (2) 申請查驗義務人為公司（商業），除進口未變性酒精供製藥酒業者外，其申請進口酒類業者應取得酒進口業許可執照。

The obligor of the application may only be organized as a company (or business). Moreover, applicants for the inspection of imported alcohol shall obtain a license permit in advance excluding importing for pharmaceutical manufacturing industry purposes.

3. 進口酒類基本資料區：請依照進口酒類之標示內容逐項填寫，或逕於基本資料申報表上黏貼標示樣張（含前標與中文背標，免全圖）。

“Basic Information of Imported Alcohol”: Please fill in the items according to the imported wine, or paste the labeling sample on this application form (including the front label and the Chinese back label; the full picture is exempt).

4. 「包裝方式」欄及「包裝材料」欄：係指酒品最小單位之包裝方式及包裝材料。請以勾選方式為之，不可複選。

“Packaging Method” and “Packaging Material”: Refers to the packaging methods and packaging materials of the smallest unit of alcohol. Please check the correct one; single choice only.

5. 「包裝規格及單位數量」欄：請填明申請進口酒品之包裝方式及進口酒品包裝單位之數量。

“Specification of Packaging Method and Quantity”: Please fill in the specification of

packaging method and quantity.

6. 「申請查驗情況」欄：指本次申請查驗酒類是否曾經查驗而言，請以勾選方式為之，不可複選。屬輸入時曾經查驗合格及曾檢附國外檢驗之證明文件者，請填寫該查驗申請書號碼。\*如屬曾申請查驗進口相同酒類，前已檢附其標示資料(含電子檔)經財政部審核通過，且本批酒類標示與曾檢附之標示電子檔完全相同時，免重複檢附。

“Application Status”： Refers to whether the alcohol products specified in this application has ever been inspected. Please check the correct one; single choice only. Those who have been previously inspected and found to be in conformity with the standard hygiene requirements and have attached with hygiene certificates stipulated by the central competent authority, please fill in the inspection application number. \*If the alcohol products and labeling sample are the same as those that have been previously inspected and found to be in conformity with the standard hygiene requirements, the labeling sample (including electronic files) is exempt.

7. 「本批進口酒類之標示樣張及型錄、說明書或圖樣之檢附方式」欄：請依實際情況就以紙本、磁片、光碟或網路傳送方式擇一勾選，「電子檔檔名」欄請以「進口報單號碼-項次」標明。符合前項說明之免重複檢附者，請勾選免檢附。

“Format for providing labeling sample and category, written explanation or design of this lot of imported alcohols”： Please select one of the methods, paper, disk, CD or transmit by Internet. “Name of the Electronic File”： please indicate with “Import Declaration No.-Items”. Those who do not need to repeat the appraisal in accordance with the preceding paragraph is exempt from providing said materials.
