1. This application is to be used to apply for retesting of imported alcohol which did not conform to the stipulations after inspection. Each lot of alcohol can apply for retesting at most once.
2. 「Date of Receipt」 The date Ministry of Finance receives this application. Please do not fill in.
3. 「Application No.」 The number of this application. Please do not fill in.
4. 「Original Application No.」 The original application number on the first application for inspection of imported alcohol.
5. 「Obligor of the Application」 Alcohol importer or company with a license permit.
6. 「Uniform No.」 The uniform number of the obligor of the application.
7. 「Address」 The location of the organization of the obligor of the application.
8. 「Tel No.」 The contact phone number of the organization of the obligor of the application.
9. 「E-mail」 The E-mail address of the obligor of the application.
10. 「Signature of the Obligor of the Application」 The seals of company and representative of the obligor of the application.
11. 「Place or Code of Goods Storage」 The original place or code of goods storage on the application for inspection of imported alcohol.
12. 「Import Declaration No.」 The original import declaration number on the application for inspection of imported alcohol.
13. 「Date of Import」 The original date of import on the application for inspection of imported alcohol.
14. 「Items、Brand Name (Chinese/English)、Import Declaration Items、Product Category、Alcohol Content、C.C.C. Code & Inspection No.、Specification of Package and Number of Units、Total Quantity (liter)、Special Indication」 The original information on the application for inspection of imported alcohol.
15. 「Disqualified Item(s) of Original Test」 The information of inspected alcohol on the disqualification notice.
16. 「The agent of Obligor of the Application、Attention、Tel. No、E-mail、No. of Letter of appointment、Period of Validity」 The original information on the application for inspection of imported alcohol.
17. 「Signature of the Agent of the Obligor of the Application」 The seals of company and representative of the agent of the obligor of the application.
18. 「Examination」 is for the use of the authority-in-charge. Please do not fill in.
